What did your chapter do to train or engage the public? We're looking for anything you did to teach non-journalists about journalism.

We held a panel that discussed the updated public records and open meeting law in Massachusetts. The audience, which packed a bar, included reporters, lawyers and a representative of the Massachusetts ACLU. Discussion was robust and extended beyond the agenda to include issues of public transparency, government accountability and the public's right to know. Our event brought lawyers and reporters together in concerted action to advance a better public records bill in the near future. We partnered with the New England First Amendment Coalition to host the event.

Student outreach

We held our Election 2016 Coverage panel at Northeastern University in Boston to reach out to college students who are looking to work in the field of journalism. We also spoke with journalism students at the University about SPJ in March as they are looking to reestablish their own student chapter.

We also, for the first time, coordinated an event in the predominantly African-American and Latino community of Roxbury in Boston at Roxbury Community College. We partnered with the Muslim Student Association and the Muslim Justice League (a new organization of younger Muslim Americans in the Boston Area) to present a panel which explored the expression of First Amendment freedoms in the age of the War on Terror. The Muslim Student Association pledged to follow up the event with a "Know Your Rights" event of its own as well as a "Meet the Muslims" SPJNE-sponsored lunch likely scheduled for the upcoming year.
